

WHAT IS EVUS? 什么是签证更新电子系统(EVUS)?

As part of the agreement to extend visa validity, nationals of the People's Republic of China holding a maximum validity (normally 10-year) B1/B2, B1 and B2 visas will be required to complete an online form to update certain information.

WHAT IS EVUS? 什么是签证更新电子系统(EVUS)?

Travelers will need to have a valid EVUS enrollment prior to traveling to the United States. An EVUS enrollment is valid for two years or until the traveler obtains a new passport or "B" visa, whichever comes first.

旅客在赴美旅行之前将需要拥有有效的EVUS登记。一次EVUS登记的有效期为两年,或者直到旅客获得新的护照或B类签证时为止,以先到期者为准。

WHO NEEDS TO ENROLL IN EVUS? 谁需要进行EVUS登记?

- 所有10年期(最长有效期)B1、B2和B1/B2签证的持有者,包括14岁及以下和80岁及以上的旅客都必须进行EVUS登记;
- 必须持有中华人民共和国护照;
- 护照类别(普通、公务普通、 公务、外交)并无差别;
- 其它签证类型(F、J、H等) 不需要进行EVUS登记;
- 短于最长有效期的B1、B2和 B1/B2签证,<u>不需要</u>进行EVUS登 记

- ALL 10-year (maximum validity) B1, B2 and B1/B2 visa holders including travelers 14 and under and 80 and older must enroll in EVUS;
- Must hold a People's Republic of China passport;
- Passport type (Regular, Public Affairs, Service, Diplomatic) does not matter;
- Other classes of visa (F, J, H, etc.) do not have to enroll in EVUS;
- Less-than maximum validity B1, B2 and B1/B2 visas <u>do not</u> have to enroll in EVUS

When does it become mandatory to enroll in EVUS? EVUS登记于何时开始强制施行?

- On November 29, 2016, all PRC Passport holders carrying 10-year B1, B2 or B1/B2 visas must have a valid EVUS authorization in order to enter the United States.
- Travelers subject to the EVUS enrollment requirement who do not have a valid EVUS enrollment must enroll and be approved before being able to board a plane or enter through a land port of entry to the United States.
- 从2016年11月29日开始,凡是有10年期B1、B2或 B1/B2签证的中华人民共和国护照持有者都必须获得有 效的EVUS批准才能入境美国。
- 那些需要进行EVUS登记但还未拥有有效的EVUS登记的 旅客,必须先完成登记并获得批准才能登机或通过陆 地口岸入境美国。

Can I Travel Before November 29? 我可以在11月29日前赴美吗?

Before November 29, 2016, 10-year B Visa holders can continue to use their visa as normal.

在2016年11月29日之前,10年期B类签证持有者可以继续如常使用其签证。



Can I Enroll Before November 29? 我可以在11月29日之前登记吗?

U.S. Customs and Border Protection (CBP) expects to begin accepting early EVUS enrollments on a voluntary basis in mid-October, before enrollments become mandatory on November 29.





EVUS status of "Successful Enrollment" means the EVUS requirement has been met for travel to the United States 1) for a validity period of two years from date of enrollment, OR 2) until the Primary passport expires ("Primary passport is the passport used to enroll that was valid and unexpired at the time of ollment), OR 3) until the visa expires, whichever occurs first. This does not guarantee admission to the United States. A U.S. Customs and Border tection officer at a U.S. port of entry will make the final determination.

If necessary, you can late the following information on a successful enrollment: 1) address while in the United States, and 2) email address. KEY INFORMATION - 重要信息

- EVUS is mobile phone friendly
- No picture or fingerprints required –
 just your passport/visa and an accepted
 form of payment;
- The enrollment process will take 10-15 minutes;
- After submission, most responses will return within 20 minutes, but some can take up to 72 hours;
- Answers to EVUS questions must be in English, but the questions will be in Mandarin;
- If an applicant has questions, a support center will be established to assist; however, all applicants must apply via the online site.

- 如果申请人有疑问,即将成立的服务中心 会提供协助;但所有申请人必须在线提交 申请。

KEY INFORMATION - 重要信息

- Enrollment is fast!
- The majority of travelers will receive authorization very quickly.
- The fee will be \$8 (approximately 53 RMB)
- The enrollment platform is expected to be available for early enrollments in mid-October.
- An EVUS authorization is valid for two years, or if the traveler obtains a new passport or maximum validity B1/B2, B1 or B2 visa, whichever comes first. Travelers do not have to submit a new form before every trip.
- Avoid inconvenience or delays if you have a 10-year visa, enroll early!
